Use/Action : Dental cleaning and polishing paste for removal of surface debris and stains on teeth.

Health Effects

Acute

Swallowed : Low toxicity unless swallowed in large amounts. May cause irritation to the digestive system.

Eye : The paste may scratch surface of eye.

Skin : Low irritation expected on contact with skin.

Inhaled : Should not be inhaled (unlikely). Irritancy unknown.

Chronic : If swallowed in large amount, may upset digestive system for short time. There are no other known long term health effects expected.

First Aid

Swallowed : Give water to drink to dilute stomach contents and seek medical attention.

Eye : Flush with flowing water for at least 15 minutes and if symptoms persist, seek medical advice. Do not rub effected area.

Skin : Flush skin with flowing water for at least 15 minutes.

Inhaled : Seek medical attention.
